NORTHVIEW CHURCH OMNIBUS RELEASE—WAIVER OF LIABILITY AND ASSUMPTION OF RISK FOR NORTHVIEW CHURCH:

Northview Church (hereafter the "Church"), a North Dakota nonprofit corporation, is organizing or planning a certain event, trip, or general activities that shall occur on a recurring basis (hereafter "Activities"). My child(ren)/ward(s) (hereafter "Participant(s)") wish to partake in the Activities. In consideration of being allowed to participate in any way in the Church's Activities, the undersigned acknowledges, appreciates, and agrees that: My Participant(s) wish to partake in the Activities and to use equipment provided by the Church. I am aware that these Activities include risks of physical injury to my Participants(s) and other participants. I hereby certify that I am at least eighteen (18) years of age and legally competent to sign this Waiver of Liability and Assumption of Risk ("Waiver") on behalf of my Participant(s). I hereby certify that as parent/guardian with legal responsibility for the Participant(s), I have given my consent to the Church for my Child(ren)/Participant(s) to partake in the Activities held by the Church. I hereby certify that my Participant(s) is able to partake in the Event(s). For the purposes of the following provisions, the term "I, my or Participant" shall refer to the individual(s) on whose behalf this Waiver has been executed, whether an Adult or a Minor Child. 1. I hereby acknowledge that their participation in the Activities is entirely voluntary. 2. If they are injured or need medical attention while participating in the Activities, I give the Church, its employees and volunteers, permission to seek medical diagnosis and treatment which in their best judgment they deem to be necessary or appropriate under the circumstances. 3. In cases of emergency, I further consent to the examination or treatment of any child(ren) for whom I am a legal guardian, by any physician duly licensed to practice medicine in the United States or any health care professional duly licensed to provide health care services in the United States, for medical care and services deemed necessary by the Church, its agents, servants, and employees. 4. I give permission to the Doctor or health care professional to provide any and all medical care they deem, in their professional opinion, to be necessary. 5. I agree to pay for any and all medical expenses incurred as a result of the use of this consent. 6. I also agree to fully release and hold harmless the Church, its pastors, employees, agents, borrowed servants, contractors and other workers, paid or volunteer, or their heirs and assigns, from any and all injuries, claims, liabilities or causes of action which may arise from my child's(ren's) participation in the Activities. 7. I personally assume all risk in connection with said Activities for any harm, injury, or damages that may befall my child(ren) as a result of their participation in the Activities, whether foreseen or unforeseen, and my child (ren) still wish to participate in the Activities. 8. In consideration of being allowed to participate in these activities and to use the Church's equipment, I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless the Church from any and all claims, demands, or causes of action, which are in any way connected with my child's(ren's) participation in these activities or use of the Church's equipment, whether owned or offered for use by various church members and/or volunteers. 9. I understand that it is my obligation to inform the management of the Church of any and all health considerations or medical conditions, including food and other allergies that would restrict my child's(ren's) participation in any and all Activities. 10. I acknowledge that I am not aware of any condition or limitation that would prevent my child's(ren's) participation in the Activities. I will not allow my child(ren) to participate in the Activities should I become aware of any such condition or limitation and will not allow my child(ren) to participate in the Activities should they have any illness or disease which I reasonably understand to be contagious to others or would put others in jeopardy of contracting such illness or disease. 11. By signing this document, I acknowledge that if anyone is hurt or property is damaged during my child's(ren's) participation in these Activities, I may be found by a court of law to have waived my right to maintain a lawsuit against the Church on the basis of any claim from which I have released them herein. 12.
